
WEBSITE PRIVACY POLICY

Morgan Phelps Limited t/a Morgan Phelps Solicitors (“**we/us/our**”) value the privacy of everyone who visits this website, www.morganphelps.com (“**Our Site**”) and only collect and use your personal data as described in this policy (“**Privacy Policy**”). Any personal data we collect will only be used as permitted by law.

Please read this Privacy Policy carefully and ensure that you understand it.

1. **Information About Us**

Our Site is owned by and operated by Morgan Phelps Limited t/a Morgan Phelps Solicitors, a limited company registered in England under company number 09955295.

We are regulated by the Solicitors Regulation Authority, with SRA ID 627560.

2. **What Does This Policy Cover?**

This Privacy Policy applies only to your use of Our Site. Our Site may contain links to other websites. Please note that we have no control over how your data is collected, stored, or used by other websites and we advise you to check the privacy policies of any such websites before providing any data to them. Please see Part 5 below regarding information that Our Site’s hosting company collects.

3. **What Is Personal Data?**

Personal data is defined by the UK GDPR and the Data Protection Act 2018 (collectively, “**the Data Protection Legislation**”) as ‘any information relating to an identifiable person who can be directly or indirectly identified in particular by reference to an identifier’.

Personal data is, in simpler terms, any information about you that enables you to be identified. Personal data covers obvious information such as your name and contact details, but it also covers less obvious information such as identification numbers, electronic location data, and other online identifiers.

4. **What Are Your Rights?**

Under the Data Protection Legislation, you have the following rights, which we will always work to uphold:

- a) The right to be informed about our collection and use of your personal data. This Privacy Policy should tell you everything you need to know, but you can always contact us to find out more or to ask any questions using the details in Part 10.
- b) The right to access the personal data we hold about you. Part 9 will tell you how to do this.
- c) The right to have your personal data rectified if any of your personal data held by us is inaccurate or incomplete. Please contact us using the details in Part 10 to find out more.
- d) The right to be forgotten, i.e. the right to ask us to delete or otherwise dispose of any of your personal data that we hold. Please contact us using the details in Part 10 to find out more.
- e) The right to restrict (i.e. prevent) the processing of your personal data.
- f) The right to object to us using your personal data for a particular purpose or purposes.
- g) The right to withdraw consent. This means that, if we are relying on your consent as the legal basis for using your personal data, you are free to withdraw that consent at any time.
- h) The right to data portability. This means that, if you have provided personal data to us directly, we are using it with your consent or for the performance of a contract, and that data is processed using automated means, you can ask us for a copy of that personal data to re-use with another service or business in many cases.
- i) Rights relating to automated decision-making and profiling. We do not use your personal data in this way.

For more information about our use of your personal data or exercising your rights as outlined above, please contact us using the details provided in Part 10.

It is important that your personal data is kept accurate and up-to-date. If any of the personal data we hold about you changes, please keep us informed as long as we have that data.

Further information about your rights can also be obtained from the Information Commissioner's Office or your local Citizens Advice Bureau.

If you have any cause for complaint about our use of your personal data, you have the right to lodge a complaint with the Information Commissioner's Office. We would welcome the opportunity to resolve your concerns ourselves, however, so please contact us first, using the details in Part 10.

5. What Personal Data Do We Collect and How?

Subject to the following, we do not collect any personal data from you.

Our Site is hosted by WordPress.com (owned by Automattic Inc.). WordPress collects certain information automatically, including your IP address, the type of

browser you are using, and certain other non-personal data about your computer or device such as your operating system type or version. Therefore in conjunction with this Privacy Policy, you should also read the WordPress/Automattic privacy policy, which can be found at <https://automattic.com/privacy-notice/>.

If you send us an email, we may collect your name, your email address, and any other information which you choose to give us. For the purposes of the Data Protection Legislation, we are the data controller responsible for such personal data.

The lawful basis under the Data Protection Legislation that allows us to use such information is article 6(1)(f) of the UK GDPR which allows us to process personal data when it is necessary for the purposes of our legitimate interests, in this case, the proper operation and functionality of Our Site. If you contact us as described above, you will be required to consent to our use of your personal data to contact you. In this case, our lawful basis for using your personal data will be article 6(1)(a) of the UK GDPR, which allows us to use your personal data with your consent for a particular purpose or purposes.

6. How Do We Use Your Personal Data?

Where we collect any personal data, it will be processed and stored securely, for no longer than is necessary in light of the reason(s) for which it was first collected. We will comply with our obligations and safeguard your rights under the Data Protection Legislation at all times. For more details on security see Part 7 below.

As stated above, we do not generally collect any personal data directly from you, but if you contact us and we obtain your personal details from your email, we may use them to respond to your email. In particular, we may use them to provide you with information, products or services you may request of/from us and which we consider may be suitable for you, where you have consented to be contacted for such purposes. Further, we may use them to carry out any necessary procedures prior to/in conjunction with entering into any contract of services. The other technical data referred to above is necessary for the technical operation of Our Site.

No emails containing your personal data and/or other personal data will be retained for any longer than is necessary and always in line with Data Protection Legislation.

We will not share any of your personal data with any third parties for any purposes other than storage on an email and/or web hosting server (unless you request this, for example, by our referring you to another professional to assist you with your query; please see Part 8 below in this regard). If you later become a client of ours, then the privacy policy that relates to how we handle our clients' data will be provided to you and will supersede this Privacy Policy.

7. How and Where Do We Store Your Data?

We will only store your personal data in the UK. This means that it will be fully protected under the Data Protection Legislation.

8. Do We Share Your Personal Data?

We will not share any of your personal data with any third parties for any purposes, subject to the following exceptions.

- If we sell, transfer, or merge parts of our business or assets, your personal

data may be transferred to a third party. Any new owner of our business may continue to use your personal data in the same way that we have used it, as specified in this Privacy Policy (i.e. to communicate with you).

- In some limited circumstances, we may be legally required to share certain personal data, which might include yours, if we are involved in legal proceedings or complying with legal obligations, a court order, or the instructions of a government authority.
- If you request that we provide your details to another company, individual, group etc to assist with your query then that will necessarily involve the sharing of your personal data.
- If you become a client of ours, then the privacy policy that relates to how we handle our clients' data will be provided to you and will supersede this Privacy Policy.

9. **How Can You Access Your Personal Data?**

If you want to know what personal data we have about you, you can ask us for details of that personal data and for a copy of it (where any such personal data is held). This is known as a "subject access request".

All subject access requests should be made in writing and sent to the email or postal addresses shown in Part 10.

There is not normally any charge for a subject access request. If your request is 'manifestly unfounded or excessive' (for example, if you make repetitive requests) a fee may be charged to cover our administrative costs in responding.

We will respond to your subject access request within one month of receiving it. Normally, we aim to provide a complete response, including a copy of your personal data within that time. In some cases, however, particularly if your request is more complex, more time may be required up to a maximum of three months from the date we receive your request. You will be kept fully informed of our progress.
